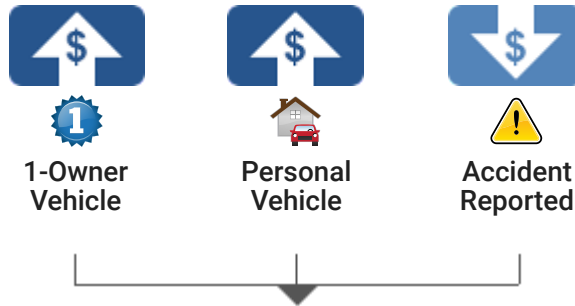



First Owner
